He recalled that many often wonder why they cannot acquire that currency in banks and the answer is that a currency that was collected from an exchange process cannot be sold to people, because it causes distortions to the economy.



misunderstood, a measure that although it creates differences, its purpose is to collect circulating cash to invest in raw materials for production processes and supply to the population.

He stressed that the restrictive measures approved by the US administration are intended to economically asphyxiate the people and cause social and political instability based on a discourse with double standards, they say that the blockade is against the State and in reality it is against the Cuban people.

Added to this is a strong subversion campaign and the resurgence of smear campaigns against Cuban medical missions, mutually beneficial with countries with which we have collaboration in the health sphere, he said.

The situation is complex and very hard, we propose to face this adversity creatively, to build the scenario of resistance without getting discouraged, we have to be able to overcome these restrictions from the improvement of our economic model, to be more efficient and productively capable, he said. .
